- HOLDERS OF A UNIFORM VISA ISSUED BY A STATE PART OF THE SCHENGEN AGREEMENT
- LONG-TERM VISA HOLDERS ISSUED BY A STATE OF THE EUROPEAN UNION
- RESIDENCE CARD HOLDERS ISSUED BY A STATE OF THE EUROPEAN UNION
- HOLDERS OF RESIDENCE PERMITS ISSUED BY ANDORRA, SAN MARINO, CANADA, JAPAN AND THE UNITED STATES, provided that they guarantee the right of readmission of the holder (see following list)
- VISA HOLDERS AND RESIDENCE PERMITS ISSUED BY THE COUNTRIES AND OVERSEAS TERRITORIES DEPENDING ON THE KINGDOM OF THE NETHERLANDS (ARUBA, CURAÇAO, SAN MARTIN, BONAIRE, SAN EUSTAQUIO AND SABA)
- DIPLOMATIC PASSPORT HOLDERS
- FAMILIES OF EUROPEAN UNION CITIZENS
- INTERNATIONAL FLIGHT CREW OF THE PARTIES TO THE CHICAGO CONVENTION ON INTERNATIONAL CIVIL AVIATION (1944)

#### ESTADOS UNIDOS DE AMÉRICA:

- Form I-551 permanent resident card (Tarjeta de residencia permanente) (válida de dos a diez años)
- Form I-551 Alien registration receipt card (Tarjeta de registro de extranjero) (válida de dos a diez años).
- Form I-551 Alien registration receipt card (Tarjeta de registro de extranjero) (validez por tiempo indefinido)
- Form I-327 Reentry document (Documento de reentrada) (válido dos años –expedido a titulares de un I-551).
- Resident alien card (Tarjeta de extranjero residente) (válida de dos a diez años o por tiempo indefinido. Este documento permite la vuelta del titular sólo si su estancia fuera de los EE.UU. no es superior a un año).
- Permit to reenter (permiso de regreso, con una validez de dos años. Este documento permite el regreso del titular sólo si su estancia fuera de los EE.UU. no es superior a dos años).
- Valid temporary residence stamp (sello de residencia temporal en un pasaporte válido) (un año de validez a partir de la fecha de expedición).

**CANADÁ:**

- Permanent Resident Card (permiso de residencia permanente, formato tarjeta de crédito).

**JAPÓN:**

- Permiso de regreso a Japón.

**SAN MARINO:**

- Permesso di soggiorno ordinario (validità illimitata) [permiso de residencia ordinario (validez ilimitada)].
- Permesso di soggiorno continuativo speciale (validità illimitata) [permiso de residencia permanente especial (validez ilimitada)].
- Carta d'identità di San Marino (validità illimitata) [carné de identidad de San Marino (validez ilimitada)].

**ANDORRA:**

- Provisional stay and work card (white). It is issued for seasonal work; The period of validity depends on the duration of the work, but never exceeds six months. It is not renewable.
- Work and stay card (white). It is granted for six months and is renewable for one year.
- Stay card (white). It is granted for six months and is renewable for one year.
- Temporary residence card (pink). It is granted for one year and can be renewed twice, for one year at a time.
- Ordinary residence card (yellow). It is granted for three years and is renewable for another three years.
- Privileged residence card (green). It is granted for five years and is renewable for periods of equal duration.
- Residence authorization (green). It is granted for one year and is renewable for periods of three years.
- Temporary residence and work authorization (pink). It is granted for two years and is renewable for another two years
- Ordinary residence and work authorization (yellow). It is granted for five years.
- Privileged residence and work authorization (green). It is granted for ten years and is renewable for periods of equal duration.
