- Non-refundable fees, payable only through <u>Debit Card / Cash payments (No Money Order</u>).
- Applications must be submitted in person. Visas must be collected in person.

Birth/Marriage certificate/Tax documents or any govt issued document (English/Spanish only), passport copy of sponsor, notarized letter assuming full financial responsibility and last 3 months of Personal Bank Statement.

## Financial Aid, Scholarships or other economic aids:

Proof of financial aid, loans, scholarships, or other economic assistance covering the minimum monthly amount required.

#### **HEALTH INSURANCE:**

Proof of public or private health insurance issued by an insurance provider authorized to operate in Spain (the insurance entity must be registered in the list of insurance and reinsurance entities of the General Directorate of Insurance and Pension Funds). Health insurance must cover similar benefits to National Health System services in Spain (articles 7 and following of Law 16/2003, of May 28, on cohesion and quality of the National Health System) and have no co-payments and no deductible. If the policy has a limited coverage to a specific amount, this will not be less than thirty thousand euros, without prejudice to the individual assessment of the application. The insurance contract must be maintained during the authorization period.

<u>Volunteers:</u> <u>in addition</u> to health insurance, a copy of the civil liability insurance policy of the receiving organization must be provided.

#### FOR STAYS OVER 180 DAYS, THE FOLLOWING ADDITIONAL DOCUMENTS ARE MUST BE PROVIDED: :

- \* 3. Original and copy of Criminal Background check (for applicants 18 years old or over) of the US and, if applicable, places of residence during periods of more than 6 months within the last 5 years
  - 4. The Criminal Background Check must be issued within the last 6 months prior to visa application.
  - 5. The Criminal Background Check must be issued by the US Department of Justice (FBI); State or Local Police Background will not be accepted

- <u>Criminal background check must be authenticated with the Hague Apostille.</u> The apostille must certify the signature on the Criminal Background check, not other signatures (e.g. apostilles certifying the signature of a notary's seal on the criminal check will not be accepted).
- Criminal checks must be translated into Spanish (official translation).

#### \* Medical certificate:

Medical certificate (and photocopy) verifying that the applicant does not suffer any diseases that could have serious repercussions for public health in accordance with the International Health Regulations of 2005.

- -This certificate must be issued within 3 months preceding the submission of the visa application.
- -This certificate must include a stamp from the issuing Medical Center, Doctor's name and signature, Doctor's License Number and date.
- -The certificate must be written on letterhead paper from hospital/doctor's office or on the provided template.
- -Medical certificate must be translated into Spanish (official translation). Not applicable if issued on the template provided by the Consulate (see website)
